39 Downing Street Hingham MA

Narrative:

The Site is located at 39 Downing Street in Hingham MA 02043. The property currently has a 4 Bedroom existing dwelling located on site. The work being proposed is an upgraded Septic system to an existing one.

Wetland Details:

Bordering Vegetated Wetland:

Hingham GIS has a wetland called out to be a Wooded Swamp Deciduous. In September of 2024 Colin McSweeney delineated the relevant wetland boundaries with flags labeled A1-A6. All Flags were located on site with surveying equipment.

FEMA Flood Zone:

A flood zone AE (elevation 27.2') is located to the west of the property. Location of this flood zone was taken off the Hingham GIS flood layer effective 07/03/2024.

Work Description:

The replacement of a failing system is being proposed in pre-existing lawn area. A new 2000 Gallon two compartment pump tank will be installed to pump the effluent to a Distribution

Box that feeds by Gravity to a GeoMat leaching System. Under the remedial use permit the Geomat system is considered an alternative SAS with treatment.

Location Narrative:

The location of the field was chosen for the following reasons. The first one due to lot constraints and setbacks from house and property line the field could not be placed anywhere outside the 100' Buffer zone. The area chosen for the new field is outside the 50' buffer zone all within a pre-existing lawn area. The tank will be placed outside the 100'.
